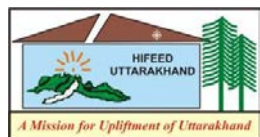

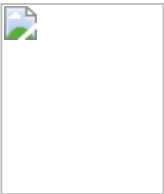

SUTRA's main framework for its activities is Gender and Governance. 6. Students with medical history and in need of special food, should inform in advance and SUTRA Community Kitchen in-charge shall inform whether SUTRA is in position to oblige or not.

Other Rules/Regulations:

- A. Interns are expected to have humility towards community members and Fieldwork staff of SUTRA.
- B. Interns are expected to follow the daily routine at SUTRA and weekly Shramdaan (community work) to keep the campus clean.
- C. Interns are expected to complete their assignment within given time frame

- D. If the assignment is given by SUTRA, all the local travel expenses are borne by SUTRA. If Interns choose their own assignment, travel expenses shall be borne by Interns.

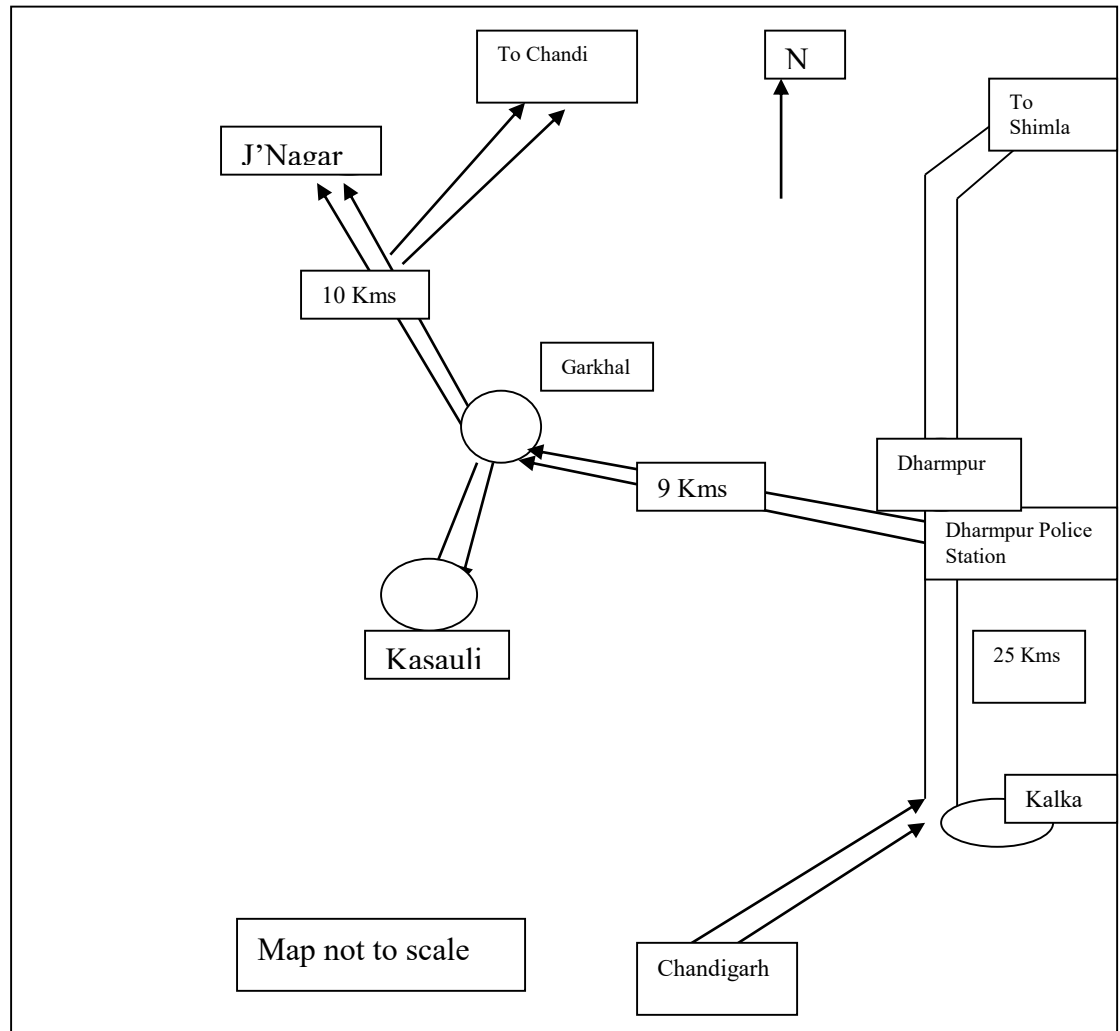

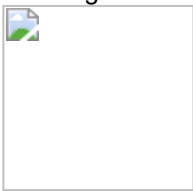

Dear Tribhuvan Das Foundation,

We would like to express our gratitude for accepting the following DA-IICT students for the Rural Internship, 2016.

The Internship is a statutory requirement of the B Tech degree of DA-IICT that all students take up in a rural location at the end of their Third Semester of study. The duration of the Rural Internship is from December 7 to December 31st 2016. During the Internship period, the student will carry out the work assigned by your organization.

The Institute awards students a Pass or Fail grade for the Internship based following components:

1. Evaluation provided by the organization and
2. The students' report submitted to DA-IICT.
3. Poster Presentation

You are requested to fill a confidential evaluation report of the Intern's performance and hand it over to the student in a sealed envelope on the last day of the Internship.

Students are not permitted any leave during the internship period. If they approach you for leave, please ask to contact us. However, they may be allowed to leave the village on Sundays only during the daytime for withdrawing money from ATMs, purchasing medicines, etc.

While the students have been briefed about behavioral, safety and security issues during their internship, I request you to ensure that the student does not get into any undesirable situation. **If you find any student involved in undesirable situation or leave the village for any reason, you may send them back to DA-IICT and appropriate disciplinary action will be taken.**

1. Would you mind deciding the exact description of the work that the each of the following students would be assigned with before they arrive at your organization on 7th December?
 - Number one complaint we hear from the students from the prior years is as follows: "when we went to [any xyz] NGO, no one there knew what work to assign us. We spent more than a week out of our three weeks stay there just idling, while they figured out what work to give to us."
 2. Would you please closely monitor the work that each student does during the three-week period that he/she is with you? We will grade the students' work at your organization based on the feedback that we receive from you at the end of their internship.
 - Duration of the Rural Internship is from December 7 to December 31st, 2016. However, due to uncertainty of train reservations, we have allowed students to reach at the most two days late and leave at the most two days early.
 - Students are not permitted any leave during the internship period. There may be exceptional cases in which a student may need to take a certain duration of leave during these 3.5 weeks. I will convey to you a prior approval of such exceptional cases. If any other student approaches you for leave, please ask to contact us. Please flag any student that takes leave without the prior approval.
 - Please allow the students to leave the village on Sundays only during the daytime for withdrawing money from ATMs, purchasing medicines, etc.
 - While the students have been briefed about behavioral, safety and security issues during their internship, I request you to ensure that the students do not get into any undesirable situation. If you find any student involved in undesirable situation or leave the village for any reason, you may send them back to DA-IICT and appropriate disciplinary action will be taken.
 3. Would you please preferably provide the students with, or at least help them find, a suitable and a safe accommodation.
 - This is the number one concern that the students who will be reporting to you have. Your help in this regard would be greatly appreciated.
 4. Hoping that you'll take good care of our students and nurture them with the good values that they'll inculcate and the knowledge that they'll gather while working with you. Please keep in mind that they will appreciate and stand to gain a lot by your mentoring and guidance. Please set clear tasks and goals (see item 1 above) so as to ensure that you get something of tangible value from the students over their internship period.

As you may be aware (based on our collaboration over past several years), our B. Tech. curriculum requires that all students to undertake a four-week Rural Internship at the end of their Third Semester.
