AS YOU ARE VERY MUCH AWARE, <u>RAGGING IS A CRIMINAL OFFENCE</u>. THE UGC HAS FRAMED REGULATIONS ON CURBING THE MENACE OF RAGGING IN HIGHER EDUCATIONAL INSTITUTIONS, IN ORDER TO PROHIBIT, PREVENT AND ELIMINATE THE SCOURGE OF RAGGING. <u>THESE REGULATIONS HAVE BEEN NOTIFIED AT THE INSTITUTE WEBSITE AND ALSO IN THE ANNOUNCEMENT FOLDER OF THE INSTITUTE E-NOTICE BOARD</u>.
